### NEW MEXICO SCHOOL BOARDS ASSOCIATION 2019 LEGISLATIVE PRIORITIES

#### I. Introduction

The mission of the New Mexico School Boards Association (NMSBA), as an advocate for public education, is to provide leadership and services that enable local boards of education to govern effectively. Through NMSBA, local boards of education are involved in the legislative process to achieve needed school and program reforms. Each of these efforts is focused on the goal that every student is entitled to a free and quality public education.

Every year, NMSBA initiates a legislative process that enables local school boards to express their opinions on current educational issues. These opinions are collected through a resolutions development process. Following a comprehensive analysis of all resolutions, the NMSBA Resolutions and Legislative Committee recommends legislative priorities to the membership for adoption. At the NMSBA Annual Convention on December 7<sup>th</sup>, the 2019 Legislative Priorities were adopted and now represent the collective voice of New Mexico's 89 school boards and over 450 school board members.

The 2019 New Mexico Legislative Session will be a challenging 60 days with many important issues to deal with. We trust our Legislative Priorities will be carefully considered by New Mexico's Legislative and Executive Leaders.

#### **II. GUIDING PRINCIPLES**

In analyzing legislative proposals in the interim and during the legislative session NMSBA uses three guiding principles:

#### Unfunded Mandates

NMSBA opposes legislation that mandates public schools to implement new programs or initiatives without providing the necessary financial resources. NMSBA will continue to advocate for funding for unfunded mandates that currently exist.

#### Local Control

One of the important components of a successful public education system is local decision-making. NMSBA believes that decision making at the district level must be preserved and expanded and opposes any legislation that attempts to diminish or take away this authority.

#### Adequate Funding

NMSBA believes funding for public schools, which is the primary responsibility of the state, should be increased to a level that assures every student will receive an adequate education based on their needs. Funds should be appropriated in a manner that preserves the ability of school boards to allocate funds within their districts based on the diverse needs of their students and communities.

#### III. 2019 LEGISLATIVE RESOLUTIONS/PRIORITIES

#### LOCAL CONTROL

- 1. Oppose efforts to remove or reduce powers of elected local school boards in areas such **local alternative demonstration of competency graduation policies** (Ruidoso)
- Support greater local school board decision making including the replacement of current teacher evaluation and school grading systems (Las Cruces)

#### **ADEQUATE FUNDING**

- 3. Calls for increased and **sufficient funding for public education** as called for in the state constitution; funding for **mental health, school safety, pre-k and other unfunded programs**. (Las Cruces)
- 4. Request increased funding from the Land Grant Permanent Fund to comply with the constitutional mandate for all students, including those defined as "At-risk" and requests resources and input from public schools in order to comply with the Martinez/Yazzie Case. (Bernalillo)
- 5. Calls for funding to increase **teacher starting salaries to \$50, \$60 and \$70 thousand** and **principal starting salaries to \$80, \$90 and \$100 thousand**. (Farmington)
- 6. Calls for immediate steps to provide additional funding for Regional Education Cooperatives. (Mora)
- 7. Calls on the Legislature to **fully fund all-day pre-school for 4-year olds and half-day pre-school for 3-year olds.** (Farmington)
- 8. Calls for the development and implementation of a **statewide technology plan**, **recognition of the importance of careers in technology and computer science**, and **funding for professional development for all technology staff.** (Gadsden)
- 9. Supports funding, regulatory and statutory adjustments for **high school career and technical pathways** and **student financial assistance for job-market opportunities**, (Rio Rancho)
- 10. Calls for research to **determine sufficient funding levels for instructional materials, funding for instructional materials** and **improved distribution oversight**. (Albuquerque)
- 11. Calls for additional funding for schools wishing to implement **Community Schools Programs** and recommends use of the state statute as an implementation guide. (Albuquerque)

#### SCHOOL SAFETY

- 12. Calls on the Legislature to increase funding for **capital improvements**, **renovation**, **technology infrastructure** and **school safety and security** through the PSCOC. (Farmington)
- 13. Prioritize funding for school safety, pass legislation that protects students and staff and provide school safety training assistance to school districts. (Los Alamos)

- 14. Join in **finding a solution for acts of violence**; require and **strengthen universal background checks**; and *prioritize school safety* to include increased **funding for counselors, mental health staff, psychologists and social workers**. (Albuquerque)
- 15. Embed mental health support in public schools and provide adequate funding to support healthy mental, social, and emotional health and student well-being in our schools. (Gadsden)
- 16. Provide adequate, ongoing funding for the provision of **behavioral and mental health services** and **student well-being** in support of public schools. (Rio Rancho)
- 17. Allow **retired police officers to return to work** as school resource officers **without penalty** or negative impact to retirement pension or benefits. (Farmington)
- 18. Requests statutory and regulatory **guidance in utilizing armed school security guards** and calls for **training in the area of restorative justice**. (Rio Rancho)

#### **LOCAL ELECTION ACT**

- 19. Calls on the Legislature to make needed changes to the Local Education Act; allow districts to conduct inperson special elections; determine the legality of making contributions from the State Equalization Formula to the Local Election Fund. (Santa Fe)
- 20. Calls on the Legislature to **reimburse districts for special elections** and make **other needed changes** to the Local Election Act and related bond and mill levy statutes. (Albuquerque)

#### **OTHER PRIORITIES**

- 21. Calls for adoption of a platform that demands the **immediate end to forcible and traumatic separation of children from their families by the federal government in any community in New Mexico**. (Las Cruces)
- 22. Support legislation to define "ethnic studies" and allow districts to develop ethnic studies curriculum which would satisfy social studies credit requirements. (Las Cruces)
- 23. Calls on the Legislature, PED and HED to guarantee equitable access to dual credit programs by adopting a statement of purpose and mandating equal access by higher education institutions. (Gadsden)
- 24. Support the academic success and safety of New Mexico's LGBTQ youth by recognizing the unique challenges they face and by developing data-driven strategies to improve their safety and education outcomes. (Gadsden)
- 25. Create an **exemption from Inspection of Public Records Act** allowing school boards to **release only the final three candidates** for superintendent positions. (Albuquerque)
- 26. Support legislative action allowing retired teachers and other licensed professionals to return to work immediately without the required 12-month wait out period or otherwise compromise their return to work status. (Las Cruces)
