Johnson-O'Malley Act

- 25 Code of Federal Regulations (25 CFR), Part 273
- Federally funded program BIA Navajo Nation LEA (subcontract)
- Passed by Congress in April 16, 1934

Dewey W. Johnson and Thomas O'Malley, US Congressmen



Native American Parents – Brief History of Indian Education

- BIA and boarding schools punished parents who did not send their children to boarding schools
- Poor conditions and psychologically and culturally devastating experiences of Native American children
- Former policies and practices has resulted in barriers between schools and parents
- Parents were, historically, excluded from their children's education
- Today, parents are expected to be involved
- School educational/cultural values vs Native American values

Roles and Responsibilities of the Indian Education Committee (25 CFR, Section 273)

- 273.15 Establishment of IEC elected by parents of eligible Native American students
- 273.16 Powers and duties of IEC Vested with the authority to participate fully in the planning, development, implementation, and evaluation of all programs (273.4 Policy of maximum Indian participation)
- 273.17 Programs approved by IEC All programs shall be developed and approved in full compliance with the powers and duties of the IEC

Recommendations

- Become familiar with 25 CFR Section 273 Johnson-O'Malley Act
- Learn and understand the history of Indian Education
- Develop and maintain a healthy working relationship with the IEC
 - Hold informal meetings with the IEC officers/IEC members and Board members/Superintendent (district priorities, IEC priorities, expectations, parent involvement, common goals, etc.)
 - Attend IEC meetings and JOM sponsored activities
 - Ensure that your program manager is knowledgeable in school/district policies, problem-solving, program implementation, and strategic planning. Provide proper training and support to your JOM personnel.

Recommendation - continue

- Use the IEC as an asset to your school district. Seek the strengths that parents have to offer.
- Provide leadership professional development for parents and invite your IEC members.
- Communicate with your IEC on a regular basis.
- Include the JOM/IEC accomplishments in district newsletters, website, announcement, etc.
- Agree to disagree Create a relationship of mutual respect and an environment where individuals can take risks safely.
