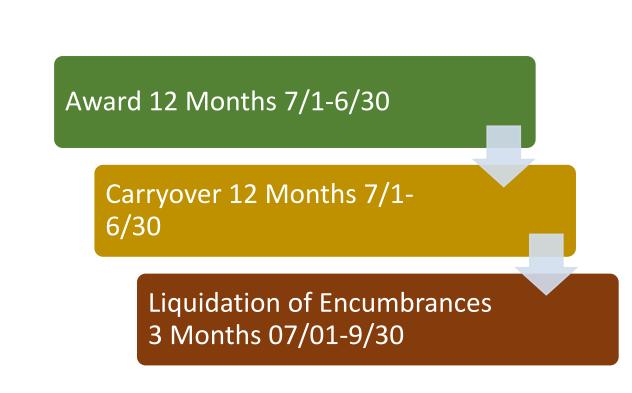

Federal Funds – 27 Month Cycle

Award – Initial encumbrance and expenditure period

Carryover – Encumbrance and expenditure of any remaining balances (modification of expenditure requires application modification)

Liquidation of Encumbrances – No new obligations, payment for items received but not paid by 06/30

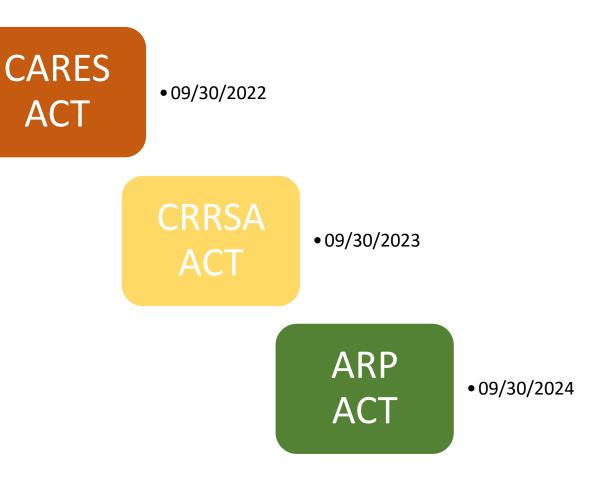


Budget Cycle

- Appropriation This is where the legislative body has expressly provided guidance on who is eligible for the funds, the restriction on uses and the total amount of funds available.
- Application LEAs detail how funds will be utilized
 - Think about who might need to be involved in this process from the start
 - Administration, Curriculum, HR, Procurement, Program Experts, Maintenance/Construction, Business, Food Services, Transportation, Technology, etc....
 - Avoid things like: generalizations (ex: Professional Development without actionable data), "Supplies", Hiring Hard to fill positions, New Software/Programs without support.
- Award The official award notification is submitted
- Initial Budget Approvals Board of Education, NMPED
- Budget Revisions Board of Education, NMPED

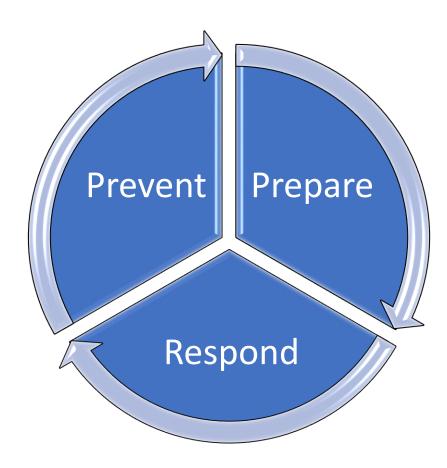
Communication

- Tone at the Top
- Make sure all involved understand the Who, What, When, Where, Why.
- CARES, CRRSA and ARP Application
 - Identify key personnel
 - Create benchmarks for expenditure and expectations
 - Set meetings to discuss benchmarks

Allowable Categories FAQ

The activities that are listed in section 18003(d) of the CARES Act, section 313(d) of the CRRSA Act, and section 2001(e) of the ARP Act that an LEA may support with ESSER funds are:

1. Any activity authorized by the ESEA, including the Native Hawaiian Education Act and the Alaska Native Educational Equity, Support, and Assistance Act (20 U.S.C. 6301 et seq.).

2. Any activity authorized by the Individuals with Disabilities Education Act (IDEA) (20 U.S.C. 1400 et seq.).

3. Any activity authorized by the Adult Education and Family Literacy Act (AEFLA) (29 U.S.C. 3271 et seq.).

4. Any activity authorized by the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins V) (20 U.S.C. 2301 et seq.).

5. Any activity authorized by subtitle B of title VII of the McKinney-Vento Homeless Assistance Act (McKinney-Vento) (42 U.S.C. 11431 et seq.).2

6. Coordinating preparedness and response efforts of LEAs with State, local, Tribal, and territorial public health departments, and other relevant agencies, to improve coordinated responses among such entities to prevent, prepare for, and respond to COVID-19.

Allowable Categories

7. Providing principals and other school leaders with the resources necessary to address the needs of their individual schools.

8. Activities to address the unique needs of low-income children or students, students with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and children and youth in foster care, including how outreach and service delivery will meet the needs of each population.

9. Developing and implementing procedures and systems to improve the preparedness and response efforts of LEAs.

10. Training and professional development for staff of the LEA on sanitation and minimizing the spread of infectious diseases.

11. Purchasing supplies to sanitize and clean the facilities of the LEA, including buildings operated by such LEA.

12. Planning for, coordinating, and implementing activities during long-term closures, including providing meals to eligible students, providing technology for online learning to all students, providing guidance for carrying out requirements under the IDEA and ensuring other education services can continue to be provided consistent with all Federal, State, and local requirements.

Allowable Categories

13. Purchasing educational technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and students with disabilities, which may include assistive technology or adaptive equipment.

14. Providing mental health services and supports, including through the implementation of evidence based full-service community schools.

15. Planning and implementing activities related to summer learning and enrichment and supplemental after-school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of low-income students, students with disabilities, English learners, migrant students, students experiencing homelessness, and children and youth in foster care.

16. Addressing the academic impact of lost instructional time among an LEA's students, including low-income students, students with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and children and youth in foster care, including by—

a. Administering and using high-quality assessments that are valid and reliable to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiating instruction.

b. Implementing evidence-based activities to meet the comprehensive needs of students.

c. Providing information and assistance to parents and families on how they can effectively support students, including in a distance learning environment.

d. Tracking student attendance and improving student engagement in distance education.

Allowable Categories

17. School facility repairs and improvements to enable operation of schools to reduce risk of virus transmission and exposure to environmental health hazards, and to support student health needs.

18. Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and non-mechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door repair and replacement.

19. Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the CDC for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff.

20. Other activities that are necessary to maintain the operation of and continuity of services in the LEA and continuing to employ existing staff of the LEA.

In determining how to prioritize its funds, an LEA should consider how to use those funds to safely reopen schools for full-time instruction for all students, maintain safe in-person operations, advance educational equity, and build capacity. An LEA may provide services directly or enter into an agreement (e.g., a contract or interagency agreement consistent with procurement requirements or otherwise legally authorized) for allowable activities under ESSER. An LEA is not authorized to award sub-grants with ESSER funds.

OIG Audit Example

State of Iowa Audit Letter

FACTS

- October 30, 2019 Iowa signed the Workday contract to encompasses three key components: (1) the Human Capital Management system(Live July 2021); (2) the Financial system (Live June 2022); and (3) Adaptive (Live October 2020), a budgeting and analysis system.
- Total replacement costs for system were \$20.1 million to be paid in installments as work was completed.
- Iowa used \$21 Million from the CARES Act Funds to pay for these upgrades.

OIG Questions and Iowa Answers

OIG Q: How did the Funds meet the requirements of the CARES Act Funds

Iowa A: "in March 2020 and the following months of this unprecedented public health emergency, the need for these upgrades, particularly the Human Capital Management system and Adaptive became even more acute." These cloud-based systems will permit State government "to productively continue functioning when many state employees are operating remotely to reduce the risk of transmission of coronavirus. Second, the Human Capital Management system will better permit the State to swiftly adjust to changing requirements caused by the emergency—whether that is new categories of leave or other processes necessitated by the emergency—without engaging in 1950s-era reprograming. Third, the Adaptive system provides a new tool for our state agencies and leaders to plan, model, budget, and forecast to properly respond to the public health emergency and its second-order economic effects."

OIG Q: Was the Contract in anyway modified to meet additional requirements related to COVID-19.

Iowa A: There were no changes or modifications to the contract, although the implementation of this contract is critical to the State's response to the pandemic.

What do you think the outcome of this audit was?

Reminders

- Uniform Guidance applies Reasonable, Necessary, Allowable and Allocable
- ARP Includes additional Provisions that CARES & CRRSA do not:
 - LEA's must post, within 30 days of receiving allocation, their plan of safe return to inperson instruction and continuity of services.
 - LEA must accept public comment prior to publication and take public comment into consideration when creating the plan.
 - 20% must be set aside to address <u>learning loss</u>
 - Maintenance of Equity for High Poverty Schools
 - LEA must submit the plan for the funds use to the SEA.
- You can change your application at any time you must request the adjustment and receive approval from Title I Bureau prior to making budget adjustments or obligating funds.
- Beware of Funding Cliffs

Davis-Bacon

- The Davis-Bacon and Related Acts, apply to contractors and subcontractors performing on federally funded or assisted contracts in excess of \$2,000 for the construction, alteration, or repair (including painting and decorating) of public buildings or public works. Davis-Bacon Act and Related Act contractors and subcontractors must pay their laborers and mechanics employed under the contract no less than the locally prevailing wages and fringe benefits for corresponding work on similar projects in the area. The Davis-Bacon Act directs the Department of Labor to determine such locally prevailing wage rates. The Davis-Bacon Act applies to contractors and subcontractors performing work on federal or District of Columbia contracts. The Davis-Bacon Act prevailing wage provisions apply to the "Related Acts," under which federal agencies assist construction projects through grants, loans, loan guarantees, and insurance.
- For prime contracts in excess of \$100,000, contractors and subcontractors must also, under the provisions of the Contract Work Hours and Safety Standards Act, as amended, pay laborers and mechanics, including guards and watchmen, at least one and onehalf times their regular rate of pay for all hours worked over 40 in a workweek. The overtime provisions of the Fair Labor Standards Act may also apply to DBA-covered contracts.
- You need to determine if Davis Bacon Applies with the Field Operations Handbook
 - <u>Chapter 15</u> (PDF) Davis-Bacon and Related Acts and Contract Work Hours and Safety Standards Act
- Competitive Solicitations
 - Must contain compliance language
 - Contractors must comply with weekly wage payments, prevailing wage provisions and posting of all required posters on the worksite.

Domestic Preference

The Buy American Act does not apply to the ESSER or GEER grants. However, awards made under the CRRSA Act and ARP Act (i.e., ESSER II, GEER II, and ARP ESSER awards) are subject to 2 CFR § 200.322, a new regulation that applies to Federal grants made after November 12, 2020. It establishes domestic preferences for procurements under Federal grants that are subject to the Uniform Guidance. The text of the regulation follows:

2 CFR § 200.322 Domestic preferences for procurements.

(a) As appropriate and to the extent consistent with law, the non-Federal entity <u>should</u>, to the greatest extent practicable under a Federal award, provide a preference for the purchase, acquisition, or use of goods, products, or materials produced in the United States (including but not limited to iron, aluminum, steel, cement, and other manufactured products). The requirements of this section must be included in all subawards including all contracts and purchase orders for work or products under this award.

(b) For purposes of this section:

(1) "Produced in the United States" means, for iron and steel products, that all manufacturing processes, from the initial melting stage through the application of coatings, occurred in the United States.

(2) "Manufactured products" means items and construction materials composed in whole or in part of nonferrous metals such as aluminum; plastics and polymer-based products such as polyvinyl chloride pipe; aggregates such as concrete; glass, including optical fiber; and lumber.

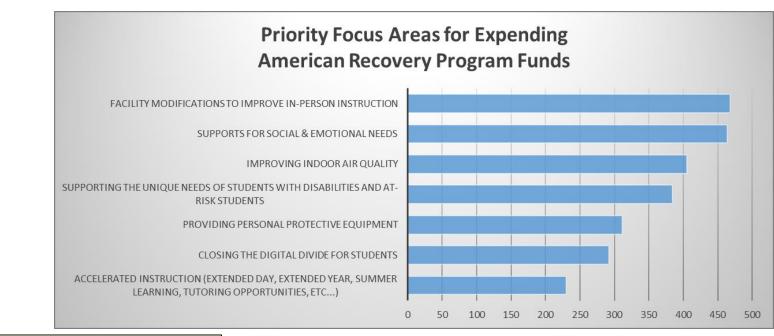
- We have expended most of our CAREs funds down and are awaiting carryover award letters to finalize.

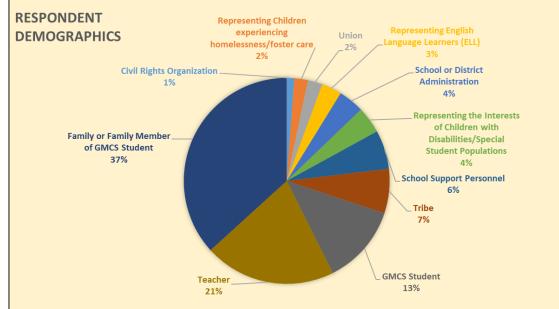
